Other Market Site configurations are accommodated by prior arrangement (Note 3) The Market Site is not a car park. All vehicles must be removed unless they are an integral part of your display presentation. Stall Site Rate is determined by the size of space occupied including vehicles and trailers. About the free Website listings (Note 6).

Notes

1. The Permanent Stallholder Permit fee entitles the applicant to a discount rate on most site fees. The fee is payable in advance to reserve an available Market Site and the discount rates ensure an overall net saving for the year for reliable attendance.
2. Corner Sites contain more area than a Double Marquee site and are the best value on a per m² basis.
3. Please ask about other Market Site configurations and sizes. Applicants with food vans and other large equipment (eg a flat tray truck) are especially encouraged to make further enquiries. Every effort will be made to accommodate you within the capacity of the Ryan Park facility and the amenity of other Market Sites.
4. The Casual Stallholder rate includes free product listings on the website (photo and text) for at least the week preceding the Market Day for which the Market Site booking is made. Photos and text can be sent by email (preferred), by **Australia Post to PO Box 1991 Katherine NT 0851** or supplied in person. Advertising material needs to be provided as soon as possible and at least 7 days in advance is ideal. Advertising material received after each Thursday prior to the Market day is not guaranteed to make it onto the website before each Saturday.
5. The Permanent Stallholder rate includes a free display page on the website dedicated to promotion of your enterprise and product range as well as free individual product listings as described above (4).
6. The free website is promoted at every opportunity in normal advertising for the Katherine Community Market (such as newspapers) and is the primary source of information. Patrons are encouraged to visit the site often to see what's going to be at the market each Saturday. Each listing has a shopping basket enquiry system so that orders can be placed directly with Stallholders in advance (for collection at the Market on the day) and to ask questions. All enquiries are passed on manually to the Stallholder. The Stallholder replies directly to the person. The website service is available to all, even if you can't drive a computer or don't have internet access.
